DECIDES AS FOLLOWS:

Article 1: A competitive entrance examination through study of files is hereby launched for entry into the Third Year of studies for the award of the Professional Master of Engineering (M.Eng, classified as GCE A/L+5) of the National Higher Polytechnic Institute of The University of Bamenda for the 2022/2023 academic year in the following departments and programmes:

Article 2: All successful applicants entering into the third year of this Institute will be required to pay training fees fixed by the Council of the University of Bamenda, in addition to University registration fees, per annum, until completion of studies at the M.Eng level. For details, please visit the website of the Institute at www.nahpi.cm.

Article 3: The competitive entrance examination is opened to Cameroonians and foreigners (foreigners pay higher fees unless regulated otherwise; please visit www.nahpi.cm to learn more) of both sexes. Applicants must hold one of the following qualifications in a relevant discipline: University Diploma of Technology (UDT); or Bachelor of Technology (B. Tech); or Bachelor of Engineering; or a Bachelor of Science in a relevant discipline with passes in O/L and/or A/L Mathematics; DIPET I or II, with permission to study for civil servants.

Article 4: Few remedial courses could be prescribed to admitted students as necessary;

Article 5: The application file shall comprise the following documents:

- A receipt (original copy) upon payment of twenty thousand (20,000) FCFA as non-refundable entrance registration fees into the account of NAHPI delivered by UBA Bank using the following bank code 10033, branch code 05204, and account number 0400400009038. NB: no other form of payment is acceptable; Payment of the entrance registration fee is a pre-requisite for the online registration.
- The submission confirmation page of a registration form duly filled and submitted by the candidate, **online**, at the NAHPI website <u>www.nahpi.cm</u> after payment of the entrance examination fees mentioned above. The submission confirmation page or Acceptance Slip should be printed and a copy of it submitted with the other documents listed below, **on or before 13**th **September 2022**.
- A certified true copy of birth certificate dated not more than three (03) months;
- A medical certificate of fitness issued by a State Medical Practitioner dated not more than three (03) months;
- A certified true copy of entry certificate or attestation of success where applicable;
- A certified true copy of either GCE A/L or Baccalaureat certificate or GCE
 Technical A/L or Baccalaureat Technical Industrial certificate, as the case may
 be;
- Certified true copies of Transcripts for the last years of study in the University
 or a Higher Institution which issued the Certificate or Attestation of success;
- A Curriculum Vitae;
- Four passport-size photographs;
- One self-addressed large envelope bearing a 400 francs CFA postal stamp;

Article 6: The complete application file should be submitted at the Office of the Director of the National Higher Polytechnic Institute in Bambili or at the Regional Delegation of Secondary Education in Bamenda, Bafoussam, Buea, Douala or Yaounde only, before 13th September, 2022. Late or incomplete application files shall be rejected.

Article 7: The assessment of the competitive entrance examination shall be by study of files and will take into consideration the following;

- a) Grades of the entry diplomas and degree: 50/100; b) Relevance of entry diploma or degree: 30/100
- c) Age of the candidate: 10/100; Duration of studies to obtain entry diploma or degree: 10/100

Article 8: A jury designated by the competent authority, shall prepare the list of successful candidates per programme by order of merit and submit it, in strict compliance, to the Minister of State, Minister of Higher Education for publication.

Article 10: The Vice Chancellor of The University of Bamenda, the Director of University Accreditations and Quality of the Ministry of Higher Education, the Director of the National Higher Polytechnic Institute, are each in his/her own sphere responsible for the implementation of this decision, which shall be registered and published in English and French wherever necessary.
